

Room Planner Contest Terms and Conditions

1. Entrants must send entries as required in the contest announcement in order to be eligible. Entries received after the deadline set forth in the contest announcement are ineligible, null, and void. Beds.sg will not be responsible for and will not consider incomplete or incorrect entries. Beds.sg is not responsible for entries that are sent but not received by Beds.sg for any reason.

2. All winners will be notified via e-mail. If the winner does not respond to the notification within five (5) business days, another winner will be chosen. Failure to respond within five (5) business days shall mean that the winner forfeits the prize.

3. Only one entry per residence will be considered for contest entry.

4. All room plans, photographs and any other content or information that you submit to Beds.sg shall become the sole and exclusive property of Beds.sg.
